CANADIAN LIFE COMPANIES SPLIT CORP.

Regular Monthly Dividend Declaration

TORONTO, ONTARIO – January 18, 2008 / CCN Matthews - Canadian Life Companies Split Corp. (“CLC Split”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable February 8, 2008 to shareholders on record as of January 31, 2008.

Since inception Class A shareholders have received a total of \$3.30 per share and Preferred shareholders have received a total of \$1.46 per share inclusive of this distribution, for a combined total of \$4.76.

CLC Split invests in a portfolio of four publicly traded Canadian life insurance companies as follows: Great-West Life, Industrial Alliance, Manulife Financial and Sun Life Financial. Shares held within the portfolio are expected to range between 10-30% in weight but may vary at any time.
